2025 School Safety Summit Committee:

 October 7 & 8, 2025 - Tammy provided an update; 70 people registered per day. Name tags are printed and ready. All rooms will have AV. Assigning duties today and will get out to everyone. Contacting Dr. Huff for the final presentation. They did have a request for interpreters and signed a contract for services. POST will have certificates available for self-reporting. Door prizes and the Grand prize will be given each day. Breakouts will have 4 rotations per day.

New Business:

Mass Fatality plans: Rich Droog attended the mass fatality training and asked what all the counties have for plans. Share if you have any. Rich contacted the Ramsey County Medical Examiner's Office, and they have morgue capacity for 50 people, plus additional space in trailers for 25 to 50 people. If we have a local Coroner, Ramsey County will not come out to the counties unless you have an agreement. Rice uses Anoka County. Eric has plan templates he can share. Rich will send the guide. We could post to the website under shared documents.

Updates:

SEMNDHC - Sailer/Flanaghan: They received funding and held an advisory meeting yesterday, reviewing continuity planning and cybersecurity. The next meeting is scheduled for October 21.

SC MN Healthcare Coalition – Weller: They have full funding. Named off upcoming training.

HSEM Update:

Mike provided updates: funding doesn't affect current grants. HSEM operations are still normal. Federal grants for 2025 were received and are under legal review. EMPG performance review for one year. The UASI grant was cut to \$3 million in total.

Shared information comes from the State Fire Marshal's Office PEAK system for EPCRA and the E-plan tool for exercise and planning. Emergency Managers will be the user administrators of the system and will need to give access to Fire Chiefs and fire staff.

E-plan data runs about a year and a half behind.

The State Disaster funding announcements should be coming soon.

Houston County: Fire in Caledonia on Monday morning, 22 people displaced, along with pets. ARC responded with financial assistance. They were back in the building in a couple of days. The bike race went well, one ambulance was dispatched, very small amount of injuries.

Mower County: working with issues of cybersecurity incident.

Le Sueur County: Mower County will be talking to their Department Head meeting about their Cybersecurity event and response.

Fillmore County: nothing to report.

HSEM: WebEOC Nexus migration information will be coming out. Mike will be sharing as he learns more. The new e-grants system is still in the works, and no date for rollout.

Goodhue County: School mapping agreements sent out. The contract will be signed next week. SE and SC counties will be sitting very well in the state.

Rice County: preplanning for churches and places of worship got a planning template he will share.

Olmsted County: nothing to report

Freeborn County: Fire departments are transitioning to NEARIS (National Emergency Response Information System) for high-quality real-time fire service data starting Jan 1. Dispatch centers will be getting information from the State Fire Marshal's Office. Training is underway throughout the state for the transition. Contact the SFM for information. Working on election planning and running exercise with the detention center. MCIT said it is better to work with shelter agreements through the ARC.

Winona County: working with bold planning on the COOP plan. HMP plan update, and City of Winona mitigation project to improve the levee system with the USACE.
