**Official meeting called to Order:**

The meeting was called to order by Ben Klinger at 9:57 am.

- The company has been around since 2010. This provides a live operational system that allows integration of all systems. In 2025, they built a Unified Command platform and mapping solution
- Cloud-based command tool
- Real-time technology for situation awareness and information sharing
- If one department purchases from a jurisdiction, then all entities have access as part of the purchase
- The system can tie equipment to the system
- The system can disseminate electronic forms, documents, photos, and maps securely to different agencies through the system. Storage up to 10TB.
- The system can ingest live data links when woken up, such as storm tracks, topography, plume modeling, VMS camera providers (schools), Arc GIS, drone, cameras, photos, airplanes, watercraft, flood gauges, and CAD information
- The system can log electronically all layers used for the entire event once activated, and resources are added, the app can be loaded by volunteers to track their locations
- Lowest cost starting for 1-25 agencies is \$25,000
